Protecting the Rights of Survivors: State Senate Bill 400



Senator Hannah-Beth Jackson (D-Santa Barbara) has introduced legislation aimed to protect survivors of domestic violence, sexual assault and stalking. Specifically, Senate Bill 400 would prohibit discrimination against and provide employment protections for survivors.

Almost one half of domestic violence victims report that they have lost a job due to, at least in part, their status as domestic violence, sexual assault, or stalking survivors. Worse, 50% of sexual assault victims report losing jobs in the aftermath of the crime, according to a 2011 study by the Legal Aid Society—Employment Law

Center, one of the sponsors of Jackson's SB 400. Other sponsors include the California Partnership to End Domestic Violence and the California Coalition Against Sexual Assault.

Although California law allows survivors to take time off work to attend court hearings or get other assistance related to their abuse, it does not prohibit employers from firing employees for being victims or require employers to provide simple accommodations, such as a new office extension number or relocating their desk. Six other states—Illinois, New York, Connecticut, Rhode Island, Hawaii and Oregon—have similar laws to protect victims from these forms of discrimination.

Jackson, who is vice-chair of the California Legislative Women's Caucus, represents the 19th Senate district, which includes Santa Barbara County and western Ventura County.

SBWPC'S 25th ANNIVERSARY...

The years 2012 and 2013 have been times for celebrations and political victories for the feminist movement. *Ms. Magazine* recently published its 40th anniversary edition. January 22, 2013, marked the 40th year since Roe v. Wade, the landmark Supreme Court decision, established the fundamental right to abortion.

The 2012 election resulted in some formidable firsts for women. Although the percentage of women in the U.S. Congress still remains low (18%), they broke several glass ceilings in both the U.S Senate and House.

And on the Central Coast, the Santa Barbara Women's Political Committee is celebrating its 25th anniversary with a year-long series of events.

However, in today's political climate, there is not only unfinished business for the feminist agenda, but an imperative need to secure the gains that have been made. To do that, **more women must run for national office starting with local and statewide candidacies.** The political process can be daunting—so how can women candidates get started in politics? Is there a pipeline and if not, can one be created?



In the late 1980s, a small group of women met for several months over dinner to discuss the lack of women in public office in Santa Barbara County. Led by

Gayle Binion, a UCSB political science professor who became the group's first president, and **Lois Phillips**, then associate dean of Antioch College, the group expanded over time.

The founders included a list of Who's Who among woman activists in the community: Ruth Ackerman, Marty Blum, Cindy Bowers, Diane Bury, Vesta Clinton, Margaret Connell, Sylvia Curtis, Anita Perez Ferguson, Nancy Franco, Carla Frisk, Hannah-Beth Jackson, Barbara Lindemann, Lily Maestas, Sandy Robertson, Mary Rose, Selma Rubin, Ruth Rodriguez Schaffer, Naomi Schwartz, Sarah Shoresman, Deb Sills, Catherine Swysen, Janet Vandevender, Marya Weinstock and Jana Zimmer. (In full disclosure, this author was also a founding mother.) We asked the question—can women have a significant

impact at the local level? Reflecting on 25 years of political activities, the answer is an unqualified YES. Using an activist model, these feminists created a pipeline to elective office.



The Santa Barbara Women's Political Committee (SBWPC) was born in January of 1988, with a raucous reception at a popular watering hole called Zelo's that brought out 250 women and men. **Betty Friedan** was the keynote speaker that evening and anti-choice opponents picketed the event.

Each of the founding Board members brought her rolodex to the outreach effort. Sharing these contacts helped get the word out across sectors and disciplines, increased attendance at events and quickly built a membership base that today includes both women and men. The time was right to organize!

From the beginning, the SBWPC defined itself as a feminist organization. Its mission states:

"The Santa Barbara Women's Political Committee is dedicated to furthering gender equality and other feminist values through political and social action, and educational activities. As a political action committee, we endorse the candidacies of women and men who actively support our goals and promote a feminist agenda." http://sbwpc.org/

During these last 25 years, the SBWPC has pursued gender equity through many avenues, but with the goal of creating social change through public policy. SBWPC's belief that female elected officials would do more to make a difference in the lives of women has since been documented by academic institutes like the Center for American Women and Politics (CAWP) at Rutgers University. Additional research from Stanford University has demonstrated that female legislators perform better than their male counterparts once in office. The organization has supported many women for school boards, city councils, boards of supervisors, the state legislature, California statewide offices, Congress and the Presidency.

In 1988, the SBWPC endorsed the candidacies of **Dianne Owens** and **Gloria Ochoa**, the first women to serve on the County Board of Supervisors. The smell of victory was sweet! During the 1990s, more women began to run for office.

Santa Barbara County has been represented by a woman in Congress since 1999. Women have comprised as much as 80% of the County Board of Supervisors, and served as mayors and district attorneys and in both houses of the state legislature. They also hold many positions on school boards and local commissions. During its 25 years, the SBWPC has endorsed and contributed financial support to 95 candidates. A total of 56 of those were women (59%). Only four of the women lost. All candidates supported the feminist agenda.

The Santa Barbara Women's Political Committee has created a culture where women in public office are the norm not the exception. Success is best demonstrated by their impact on public policy and governance. Issues and legislation introduced by women elected to office in Santa Barbara have covered a broad range of topics.

Note the wide-ranging accomplishments of women who have been supported by the SBWPC:

- Congresswoman Lois Capps has been committed to women and families by supporting legislation on health care, the environment and education including the Affordable Health Care Act;
- State Senator Hannah-Beth Jackson has emphasized domestic violence and reproductive rights. Jackson's legislation assisted victims of abuse and created access to affordable reproductive care;
- **District Attorney Joyce Dudley** has worked to expand rape laws, eliminate rape kit backlogs and increase timely testing of all kits. Dudley is a strong advocate for truancy programs;
- The late **County Supervisor Naomi Schwartz** chaired both the local First Five Children's Commission and the California Coastal Commission making children and the environment her hallmark issues;
- County Supervisor Janet Wolf has focused on health care and gender balance in public appointments. Wolf has worked to expand breast cancer digital mammography services for underserved women;
- As Mayor of the City of Santa Barbara, Helene Schneider has established a focus on living wage, housing, homelessness, human services and education.

In its early days, the SBWPC founding Board of Directors created a set of tools that enabled them to ensure the election of feminist women to office. They included:

- Position papers;
- Recruitment strategies;

- Campaign skills workshops;
- Candidate assessment teams;
- Endorsements;
- State and federal PAC money;
- Media support.

These tools are still in place today and guide the Board in their decision-making.

Many of the first candidates to be endorsed by the PAC were founding Board members. As they left to run for office, others took their place. The Board itself became a source for candidates, creating an early pipeline, joining public boards and commissions and becoming staff members to the newly-elected women.

As part of their current organizational structure, the SB-WPC has a standing pipeline committee that focuses on recruiting women for future elections.

The question of supporting male candidates arose in the early years. On the occasions when they did not have women candidates, the SBWPC endorsed men who, in turn, supported the SBWPC agenda. As a result of this policy, today the endorsement of the SBWPC is highly sought after by all candidates in Santa Barbara.

While other feminist organizations have declined or disbanded, the SBWPC has been able to sustain itself over 25 years because of a diverse board of women and a membership committed to addressing issues that are current and compelling.

With a Board of Directors of 19 women, the 2013 organization is led by **President Jane Gray** and an executive committee that includes **Lisa Guravitz**, **Yesenia Curiel**, **Carol Keator** and **Kate Silsbury**. This new generation of activists has increased the visibility of the organization and is adept at using social media. They are also reaching out to women in northern Santa Barbara County. http://sbwpc.org/board-of-directors/

In Santa Barbara County, women have achieved political and electoral success by grass roots organizing, marching, mentoring, advocating and campaigning. The organizational

model developed by the SBWPC has been tried and tested over the years and can be replicated in other communities. *The SB-WPC has worked on a local level, why not nationally?*

As a board member of the Santa Ynez Valley Natural History Society that promotes Natural History education in the Santa Ynez Valley through field trips and lectures, I am one of the founding members of the Board of Directors of the Society and I provided the legal work to form that organization.

With great joy, I participate as a volunteer counter for the Gray Whales Count, enjoying wonderful views of gray whale mothers and their babies as they pass through our channel.

APIA Caucus Honors Santa Barbara Activist Sharon Hoshida

The Asian & Pacific Islander American Legislative Caucus honored longtime community activist **Sharon Hoshida** in two special ceremonies in the state Capitol.

Hoshida, the former director of the UCSB Women's Center, received the Excellence in Public Service honor. She was first recognized during the daytime Assembly floor ceremony. Later in the evening, several hundred people gathered for a gala event at the Sacramento Convention Center organized by the Asian & Pacific Islander American Legislative Caucus. The APIA Caucus works to promote and support the history, culture and heritage of Asian- and Pacific Islander-Americans.

"Through her outreach and activism, Sharon Hoshida is one of the cornerstones of our community," said Assemblyman Das Williams, D-Santa Barbara, board secretary for the Asian & Pacific Islander Legislative Caucus Foundation. "She is a role model and inspiration for all of us."

Hoshida was a founding member of the Minority Faculty and Staff Association and the Asian-American Faculty and Staff Associations at UCSB. She advised several student groups and participated in summer bridge programs for freshmen from underrepresented populations. The Bridge Over Troubled Waters fund was established in her honor to provide emergency grants for students who are single parents at UCSB. She also served on the board of the Santa Barbara Women's Political Committee from 1998-2011. She is a founding member of the Women's Literary Festival Santa Barbara.

Sharon states, "I am grateful for this recognition, having worked for social justice issues for so many years. It is slightly amazing when you look back to see that collectively, those everyday commitments, letters, speeches, demonstrations, solidarity stands, marches, hunger fasts, organizing, early morning and late night gatherings, silent vigils, precinct walking, phone calling, banner painting, overpass protests, and just being there, adds up to an activist's life.

By my actions and my stated beliefs, I have been lucky enough to be in a position to lead by example among that population of human beings who are just beginning to emerge as their authentic selves, exploring and seeing in ways they didn't when living at home—and my favorite part—witnessing their discovery of passion, power, and potential.

I worked at UCSB for 37 years and during that time, I gave birth to our two children, now amazing and wonderful adults in their own right, but I also mentored and trained and nurtured more than 300 over those years who felt like "my kids". They and their families now populate my Facebook pages with their accomplishments and activities, giving me, in a truly meaningful way, a continued place in their lives. AND I get to continue to love and cherish them as they flutter about, making the world a better place. It is humbling to see my life as something to be honored, because I have just been showing up and doing what I believe is right."








Annual Meeting - January

This year's Annual Meeting was a spectacular event celebrating and underscoring the tremendously defining role women had in making the 2012 election a success. Along with **Senator Hannah-Beth Jackson**, **SBWPC President Jane Gray** and **Assistant Dean of the Women's Center, Kim Equinoa**, **Sandra Fluke** was welcomed by a warm and enthusiastic crowd. Ms. Fluke spoke on topics ranging from the Violence Against Women Act and Equal Pay to LGBT rights in elementary schools. Not only was she approachable, but her messages were poignant, clear and graceful—but make no mistake, she was powerful and forth-right in her speech. We were delighted to have her compelling voice and presence at out event.

Presidents' Circle Luncheon – March

The Presidents' Circle, comprised of the past presidents of our feminist non-partisan political organization, hosted their **12th Annual Luncheon** on Friday, March 8, for a packed house at the Montecito Country Club. This event offers attendees an opportunity to discuss local, state and national issues and to celebrate local elected and appointed officials who are working in support of SBWPC goals.

The luncheon keynote speaker was **Janice Rocco**, presently **Deputy Commissioner for Health Policy in the California Department of Insurance**, a current SBWPC member, and a past recipient of the Rising Star award from our organization. The audience was closely attentive as Janice gave her thoughts on "What's Next for California Women? The Affordable Care Act and Beyond." Although California is already a leader in addressing needs of those without insurance, the underinsured, and providing insurance

parity, the passage of the Patient Protection and Affordable Care Act (Obamacare) in 2010 will drive changes in federal law affecting numerous areas and millions of people.

As a deputy insurance commissioner, Janice is directly involved with implementing changes in health insurance coverage and costs—changes that will affect coverage of hospitalizations, substance abuse, rehabilitation care, doctor visits, preventive health care, emergency room visits, protection for those with pre-existing conditions, and access to contraceptives. Though health care law

changes will benefit millions nationwide, Janice warned that insurance rates for some individuals may increase. Another concern for California residents is that health care insurers are presently able to increase premium costs at will; the state department of insurance has no authority to regulate medical insurance costs. Look for a ballot initiative in 2014 asking voters to give regulating authority to the insurance commissioner. There are many details to work out as the new regulations are implemented in 2014 and beyond, and many questions yet unanswered. Janice suggested the web site **www.healthcare.gov** as a good source of accurate information.
