Re: SB 1346 (Jackson): Multiburst trigger activators - SUPPORT

Dear Senator Jackson,

On behalf of the Santa Barbara Women's Political Committee (SBWPC), I am writing to express support for SB 1346, prohibiting bumpstocks as part of banning machine guns. Our organization is one of the largest women's political committees in Santa Barbara County, with over 400 members. We advocate a diverse set of positions, (<a href="http://sbwpc.org/positions/">http://sbwpc.org/positions/</a>) and we are a partner with Santa Barbara's Coalition Against Gun Violence.

We understand that this bill amends Calif. Penal Code Section 16930 to prohibit bumpstocks or a bump fire stock attachment to a semi-automatic rifle. A bumpstock is defined as "a multiburst trigger activator" which is a device designed to be attached to a semiautomatic firearm to increase the rate of fire of the firearm, so that it mimics a fully automatic weapon producing nearly continuous automatic fire.

We believe there is no place in civilian society for this kind of weapon of war, as so recently demonstrated in the devastating Las Vegas mass shooting.
