We are aware that the Judiciary Committee and other Legislative bodies have gone to significant lengths to identify legal reforms that would help to bring about an end to the scourge of harassment and that numerous legal and policy shortcomings have been revealed. They include tolerance for legal tactics that silence victims; poor sexual harassment prevention training requirements; failure of some judges to account for the power of sexual harassment to undermine victims' civil rights; and weak standards for liability that force victims to endure unwelcome behavior at a severe or pervasive level before they are entitled to any remedy. Sexual harassment remains a serious and life-altering issue which necessitates comprehensive changes in the law. We support SB 1300 in establishing a twenty-first century legal standard that the courts can evenly apply to sexual harassment cases, in closing legal loopholes that force victim silence, and in requiring effective sexual harassment training as well as increased employer accountability.

The Santa Barbara Women's Political Committee regards SB 1300 as an important step forward in addressing the systemic abuse of women in the workplace. **Therefore, SBWPC wishes to sign on as a supporter of SB 1300.**
