The economic and public health crisis induced by COVID-19 has accelerated closures of childcare providers who were barely surviving even before the pandemic. California's working families must have access to stable childcare if our economy is ever to rebound. AB 865 supports the childcare work force and reimburses them for holding a space for a child regardless of whether the child attends. Further, it would require the State make direct deposit of contractor allocations and greater use of electronic communications to best support the needs of families. AB 865 values childcare providers as business owners and recognizes their work as an integral part of California's economy.
