On behalf of our entire membership, the Santa Barbara Women's Political Committee (SBWPC) wishes to thank you for your many years support of the Equal Rights Amendment (ERA), and particularly your repeated cosponsorship of the Equal Rights Amendment Ratification Resolution of the House of Representatives.

As you know, our position papers include strong support of the ERA and CEDAW, as follows:

Equal Rights (ERA & CEDAW)

Women are not explicitly accorded equal rights and protections in the United States Constitution. The United States is the only developed nation that has not ratified the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW), adopted by the United Nations General Assembly in 1979.

We demand the ratification of the Equal Rights Amendment and of CEDAW by the United States. (<https://sbwpc.org/positions/>)

SBWPC looks forward to the day when the ERA finally becomes the 28th Amendment to the U.S. Constitution. We want you to know that we very much appreciate your continuing advocacy.
